

PRIVACY POLICY

1. GENERAL INFORMATION

In compliance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (GDPR) and Organic Law 3/2018, of 5 December, on the Protection of Personal Data and guarantee of digital rights (LOPDGDD), COSTA TAMADABA SL informs the users of its website about the present Privacy Policy.

3. PURPOSE OF DATA PROCESSING

Personal data collected through this website will be processed for the following purposes:

- **Attention to requests and queries:** To manage requests for information and queries made by users through the contact forms.
- **Execution of contracts:** For the administrative, fiscal and accounting management derived from the contractual relationship with users.
- **Commercial communications:** Sending information about Redondo de Guayedra services and products, with the prior consent of the user.
- **Social networks:** Management of interactions on social networks and publication of content if the user has given their consent.
- **Personnel selection:** Participation in selection processes in case of receipt of CVs.

4. LEGITIMISATION FOR DATA PROCESSING

The processing of personal data is based on the following legal bases:

- **Consent of the interested party:** For the attention of queries, commercial communications and publications on social networks.
- **Execution of a contract:** For the management of the contractual relationship with users.
- **Fulfilment of a legal obligation:** For the management of tax and accounting obligations.

5. DATA RETENTION PERIOD

Personal data will be retained:

- As long as they are necessary for the purpose for which they were collected.
- For as long as necessary to comply with applicable legal obligations.



- In the case of commercial communications, until the user revokes his/her consent.
- In the case of CVs, a maximum period of one year.

6. RECIPIENTS OF THE DATA

Personal data will not be disclosed to third parties except in the following cases:

- Compliance with legal obligations.
- Provision of services by third parties with whom confidentiality and data protection agreements have been signed.
- Social networks in case of consent for publications.

7. USER RIGHTS

Users may exercise the following rights by sending a request to contact@redondodeguayedra.com with a copy of their identity document:

- **Access:** Obtain information about your personal data processed.
- **Rectification:** Modify incorrect or incomplete data.
- **Deletion:** Request the deletion of your data when they are no longer needed.
- **Restriction:** To restrict the processing of your data in certain cases.
- **Opposition:** Oppose the processing of your personal data.
- **Portability:** Request the transfer of your data to another data controller.

If the user considers that his or her rights have not been respected, he or she may file a complaint with the Spanish Data Protection Agency (www.aepd.es).

8. SECURITY MEASURES

COSTA TAMADABA SL adopts the necessary security measures to guarantee the confidentiality, integrity and availability of personal data, preventing unauthorised access and loss of information.

9. SOCIAL NETWORKS

Users who interact with Redondo de Guayedra's social networks accept the processing of their data in accordance with the privacy policy of each platform. In the event of publication of content by the user on the social networks of Redondo de Guayedra, the user will be responsible for having the necessary rights over said content.

10. INTERNATIONAL DATA TRANSFERS

If the user interacts with social networks such as Facebook, Twitter, Instagram or WhatsApp, their data may be stored outside the European Economic Area. Redondo de Guayedra recommends reviewing the privacy policies of these platforms.
